GDPR ONE YEAR ON

appy Birthday to GDPR! It has been 1 The Law (and Fines!) Applies to Everyone -This autonomy since the 1990s. It has been a huge sure at times it has felt like we can't escape it! Absoft have learned a lot and each project we have undertaken has added to this knowledge, which we would like to share with you. So, what are the main take-aways we have learned over the last year about the best ways to ensure GDPR compliance in your SAP system?

Obfuscation - A lot of the time in SAP it is not possible to simply delete data from your system therefore you have to find ways around this. We have worked with a number of customers this year to anonymise data in a way that works for them.

Retention - Managing data to comply with GDPR is not a one-off exercise - it is a constant requirement. Therefore, companies should ensure that they have robust retention strategies for how they manage data in the system going forward. Once the retention rules are defined, jobs can be set up to run in your system to ensure that any data which falls out of the retention period is obfuscated or deleted.

year since the General Data Protection may seem an obvious one, however we continue Regulation was brought into EU law, to come across SAP organisations who have bringing with it the biggest shake up to data buried their head in sand about GDPR law for their SAP data and who are keeping data in their hot topic across the tech space this year and I'm system that they shouldn't be - please don't let yourself fall into this category!

> At Absoft, we have worked with a variety of different customers and understand that each business is unique in their SAP use - that's why we offer SAP consulting tailored to your needs. Getting your SAP GDPR compliant may seem daunting, however taking a few steps to ensure that your data is compliant will pay off in the long run and will ensure you avoid any fines from the ICO. Absoft recommends undertaking an exercise to identify all the PII data in your SAP system that is to be anonymised.

AP S/4HANA is on the radar for most The SAP Readiness Check for SAP S/4HANA is find a business case that works for them, but specific organisation?

SAP are offering free tools and services that create bespoke reports based on the actual usage of existing SAP software including:

The Business Scenario Recommendations (BSR) tool provides relevant information on the business benefits of SAP S/4HANA. You need to upload an extract of anonymised transaction code usage by following the instructions, with the entire process taking 15-45 minutes. The report is emailed back to you after around a week.


Whilst the Business Scenario Recommendations tool is focused entirely on SAP S/4HANA, SAP also offer SAP Innovation and Optimization Pathfinder for SAP ERP and SAP Innovation and Optimization Pathfinder for Lines of Business reports that cover all of SAP's innovation up to an including SAP S/4HANA.

The SAP Innovation and Optimization Pathfinder may uncover benefits in stepping-stone projects as well as contributing items to the SAP S/4HANA business case. It turns up smaller projects that could prove the concept of SAP Fiori or SAP HANA in a business before the bigger investment in S/4HANA is made.

organisations and SAP teams are on a quest to helpful to understand the cost side of the business case. It offers a cloud-based dashboard showing how do you find the benefits that are relevant to a relevant information that could affect SAP S/4HANA conversion of your existing system. The setup is likely to take less than a day but it can be much longer if the prerequisites are not met.

> No automated report or free service will produce the completed business case, but the tools described help to focus on the relevant information that could be included and help SAP teams to convey those benefits to their business users to understand the potential impact on that specific organisation. Typical S/4HANA business cases are made up of a number of smaller benefits rather than a single killer item.

UNLOCKING THE VALUE IN CLOUD MIGRATION

Is your business moving to the cloud? If you are, which is your cloud of choice? ISS Sales Manager, Eilidh Clarkson tackles the million dollar question.

shrouded in confusion, and not a little mystery. And yet it has become a part of our everyday lexicon – whether that's discussing where we've saved the photos from our mobile phones, to why a move to the cloud is spearheading your company's five-year efficiency strategy.

It's the latter that I'm most interested in; you cannot turn around in business today without someone asking if you're using the cloud yet – and are you reaping the huge financial benefits associated with that move?

However, the "cloud" is such a buzz word that it can be hard not to feel the urge to adopt a "cloud first strategy"; in other words, migration of your IT systems into the cloud, in order to unlock operational and cost efficiencies. But what are those efficiencies? What do you need the cloud to achieve for you? And how much effort is required, not only to make the migration, but to then (crucially) ensure that the cloud is providing you with the results you envisaged.

The perceived risk of a cloud migration in this instance can appear to far outweigh the benefits. But to what extent do we really understand the benefits, in order to make that decision?

- ne sentence in and already the cloud is Security a cloud-based system provides options of regular updates and access to emerging technology
 - Flexibility the cloud allows you to plan for what you need today and not what you 'might' need in 3-5 years' time, providing you with the flexibility to scale up (or down) as required
 - Clarity the cloud offers constant access to real time analytics
 - Cost the received wisdom is that a "lift and shift" migration into the cloud will be instantly costeffective, relieving your organisation of aging and failing hardware that requires constant maintenance

This prepared approach to cloud migration has resulted in startling financial efficiencies for one of my clients. Based within the public sector, they reported a reduction of server hosts by 40% through landscape rationalisation, ultimately leading to a reduction of 50% in cloud hosting costs.

Microsoft have invested heavily into Azure infrastructure to support the latest SAP technologies and have announced collaborations to make data more accessible, and are empowering partners to make best use of both platforms to benefit their

One of the big take-aways from the event, was the investment in technology from Microsoft, especially around HLI (HANA Large Instances). This enables up to 80 Intel CPU cores and up to 24 TB of memory - and we're expecting an announcement soon of even larger machines! HLI has snapshot capability as standard, for taking consistent backups of both the machine and the HANA database.

Even if HLI is not suitable for your landscape or organisation, there are still many reasons to use Azure for your SAP estate. Doing so brings security, scalability, enhanced analytics, monitoring, and easier management. The benefits to your business can be seen in savings on hardware cost, avoiding overprovisioned hardware due to right sizing, faster time to market, reduced cost of physical space, and a smaller team to manage.
